As a consignor to this auction, I agree to the following:

A certificate of registry or signed Batch Transfer sheet for each animal will be supplied by me in order for Gilchrist Auction to transfer these animals to the buyer through RAAA.

All animals must be eligible for interstate shipment. Interstate health papers prepared by an accredited veterinarian will be supplied by me to Gilchrist Auction on each animal sold at least 24 hours prior to the auction and will include the pregnancy status on females selling as bred.

All animals or embryo/genetic lots that are catalogued and do not arrive at the auction and sell will be assessed a commission based on the average selling price of that animal's class. I agree to pay this commission on any animals or embryo/flush lots consigned by me that do not arrive and sell in this auction.

All animals will sell with a guarantee by the seller as outlined in the Red Angus Association of America Code of Ethical Sale Practices. It is to be clearly understood that all warranties, guarantees and refunds on any animals not meeting the standards of the RAAA Rules & Regulations shall be made by the seller to the buyer upon proof of cattle not meeting their representations in the auction.

All persons who attend the sale do so at their own risk. The seller, auction facility, auctioneer, and MO Red Angus Association assume no liability for any accidents that may occur or assume any liability for loss or injury to livestock due to theft, mysterious disappearance, sickness, improper handling or Act of God. It is to be clearly understood that the sale representatives act only as a medium between the buyer and seller. They are not responsible in any way for the failure on the part of the buyer or seller to live up to his obligations or for the truth of any warranties or representation, express or implied. Neither do they assume any financial obligations to collect or enforce collection of monies between parties. Any legal action, that may in exceptional cases be taken, must be between the buyer and seller.

Payment to seller for this auction will be made as timely as possible after verification of funds received from buyer.

Absentee Bids -- The Seller hereby gives permission to the Auctioneer/Sale Manager to accept bids, at the Auctioneer /Sale Managers discretion. The Seller understands and agrees that if absentee bids are accepted that the Auctioneer/Sale Manager and their staff will place these bids on the Absentee Bidder's behalf in a competitive nature and that the Auctioneer/Sale Manager and their staff in doing so will be acting as a Dual Agent for the Seller and the Absentee Bidder.

The above terms and conditions of sale shall constitute a contract between the buyer and seller of each animal and shall be equally binding upon both. Each sale or resale of an animal constitutes a separate transaction.
